- "* **Sec. 8.** AS 18.65.220 is amended by adding a new subsection to read:
 - (b) The council may not establish standards for employment under (a)(2) of this section or reject an applicant for admission to a police training program, or otherwise treat a person differently, solely because of the source of the person's high school diploma or equivalent credential. Nothing in this subsection prohibits the council from inquiring into the content of a secondary educational program to determine whether a person meets qualifications required for employment or for admission to a police training program."

Representative Eastman moved and asked unanimous consent that Amendment No. 1 be adopted.

Representative Ruffridge objected.

Representative Eastman moved and asked unanimous consent to withdraw Amendment No. 1. There being no objection, it was so ordered.
