They serve us well. We are grateful for the powerful leadership of DeLena, Andy J., Kevin, Tom, Donna, Genevieve, Dan O., Mike P., Conrad, and George in their places of influence as they are respected for the tasks before them...and finally for Justin, Laddie, Will, Andi S., Louise, Jesse, Frank, Thomas, Sarah, and Stanley who strive to do all they can to serve all Alaskans through the many roles that they have been called to.

I know our Legislature and Governor are working overtime to bring us a budget that serves our state best as well as many other critical issues, too numerous to mention. I pray for holy wisdom, incredible discernment, honest evaluation, and a strong sense of unity which is sometimes very difficult in these hallowed halls.
