8 **** Section 1.** AS 14.08.101 is amended to read:

9 **Sec. 14.08.101. Powers.** A regional school board may

10 (1) sue and be sued;

11 (2) contract with the department, the Bureau of Indian Affairs, or any
12 other school district, agency, or regional board for the provision of services, facilities,
13 supplies, or utilities;

14 (3) determine its own fiscal procedures, including policies and
15 procedures for the purchase of supplies and equipment; the regional school boards are
16 exempt from AS 37.05 (Fiscal Procedures Act) and AS 36.30 (State Procurement
17 Code);

18 (4) appoint, compensate, and otherwise control all school employees in
19 accordance with this title; these employees are not subject to AS 39.25 (State
20 Personnel Act);

21 (5) adopt regulations governing organization, policies, and procedures
22 for the operation of the schools;

23 (6) establish, maintain, operate, discontinue, and combine schools

1 subject to the approval of the commissioner;

2 (7) recommend to the department projects for construction,
3 rehabilitation, and improvement of schools and education-related facilities as specified
4 in AS 14.11.011(b), and plan, design, and construct the project when the responsibility
5 for it is assumed under AS 14.11.020;

6 (8) by resolution adopted by a majority of all the members of the board
7 and provided to the commissioner of the department, assume ownership of all land and
8 buildings used in relation to the schools in the regional educational attendance area, as
9 provided for in AS 14.08.151(b);

10 (9) provide housing for rental to teachers, by leasing existing housing
11 from a local agency or individual, by entering into contractual arrangements with a
12 local agency or individual to lease housing that will be constructed by the local agency
13 or individual for that purpose, or, without using for the purpose that portion of public
14 school funding that consists of state aid provided under AS 14.17, by constructing or
15 otherwise acquiring housing that is owned and managed by the regional educational
16 attendance area for rental to teachers;

17 (10) employ a chief school administrator;

18 (11) apply for and use the proceeds of a loan from the Alaska energy
19 efficiency revolving loan fund (AS 18.56.855);

20 (12) establish and maintain participation in a policy of insurance
21 as authorized by AS 14.27.010;

22 (13) exercise those other functions that may be necessary for the
23 proper performance of its responsibilities.

24 * Sec. 2. AS 14.14.090 is amended to read:

25 **Sec. 14.14.090. Duties of school boards.** In addition to other duties, a school
26 board shall

27 (1) determine and disburse the total amount to be made available for
28 compensation of all school employees and administrative officers, including, when
29 applicable, the amount necessary to pay for the district's participation in a policy
30 of insurance under AS 14.27.010;

31 (2) provide for, during the school term of each year, an educational

1 program for each school age child who is enrolled in or a resident of the district;

2 (3) withhold the salary for the last month of service of a teacher or
3 administrator until the teacher or administrator has submitted all summaries, statistics,
4 and reports that the school board may require by bylaws;

5 (4) transmit, when required by the assembly or council but not more
6 often than once a month, a summary report and statement of money expended;

7 (5) keep the minutes of meetings and a record of all proceedings of the
8 school board in a pertinent form;

9 (6) keep the records and files of the school board open to inspection by
10 the public at the principal administrative office of the district during reasonable
11 business hours;

12 (7) establish procedures for the review and selection of all textbooks
13 and instructional materials at least once every 10 years, including textbooks and
14 curriculum materials for statewide correspondence programs, before they are
15 introduced into the school curriculum; the review includes a review for violations of
16 AS 14.18.060; nothing in this paragraph precludes a correspondence study student, or
17 the parent or guardian of a correspondence study student, from privately obtaining or
18 using textbooks or curriculum material not provided by the school district;

19 (8) provide prospective employees with information relating to the
20 availability and cost of housing in rural areas to which they might be assigned, and,
21 when possible, assist them in locating housing; however, nothing in this paragraph
22 requires a school district to provide teacher housing, whether district owned, leased,
23 rented, or through other means, nor does it require a school board to engage in a
24 subsidy program of any kind regarding teacher housing;

25 (9) train persons required to report under AS 47.17.020, in the
26 recognition and reporting of child abuse, neglect, and sexual abuse of a minor;

27 (10) provide for the development and implementation of a preventive
28 maintenance program for school facilities; in this paragraph, "preventive maintenance"
29 means scheduled maintenance actions that prevent the premature failure or extend the
30 useful life of a facility, or a facility's systems and components, and that are cost-
31 effective on a life-cycle basis;

1 (11) establish procedures for providing the training under
2 AS 14.18.060, AS 14.20.149, 14.20.680, AS 14.30.355, 14.30.356, 14.30.362,
3 AS 14.33.100, AS 18.66.310, and AS 47.17.022; the procedures established under this
4 paragraph must include a training schedule that ensures that not less than 50 percent of
5 the total certificated staff employed by the district receive all of the training not less
6 than every two years and that all of the certificated staff employed by the district
7 receive all of the training not less than every four years.

8 * **Sec. 3.** AS 14 is amended by adding a new chapter to read:

9 **Chapter 27. University and School District Employee Health Insurance.**

10 **Sec. 14.27.010. University and school district employee group health**
11 **insurance.** (a) A school employer may elect to participate in a policy of insurance
12 selected by the commissioner of administration that includes health insurance
13 coverage of school employees. If a school employer makes that election, the
14 commissioner of administration shall select either a policy of group insurance under
15 AS 39.30.090 that covers state employees and school employees, or a policy of self-
16 insurance, provided by the Department of Administration under AS 39.30.091, that
17 provides insurance coverage to state employees and school employees.

18 (b) Subject to (e) of this section, a participating school employer shall
19 contribute to the group health and life benefits fund established under AS 39.30.095 an
20 amount equal to the rate of employer contribution and the rate of employee
21 contribution set by the commissioner of administration under AS 39.30.095.

22 (c) In addition to the contribution required under (b) of this section and the
23 reimbursement required under (d) of this section, a participating school employer shall
24 reimburse the Department of Administration an amount equal to the state's cost, if any,
25 of procuring necessary excess loss insurance in connection with coverage of the
26 school employees under AS 39.30.091.

27 (d) In addition to the contribution required under (b) of this section and the
28 reimbursement required under (c) of this section, a participating school employer shall
29 reimburse the Department of Administration the cost of paying insurance claims for
30 the first four months school employees are covered by a policy of self-insurance under
31 AS 39.30.091. The commissioner of administration shall allow the reimbursement to

1 be made in equal installments over a period not to exceed 10 years from the date the
2 school employer's participation in the policy begins.

3 (e) Subject to AS 23.40.070 - 23.40.260 (Public Employee Relations Act), a
4 participating school employer may require school employees to pay some or all of the
5 school employer's contribution under (b) of this section and reimbursement under (c)
6 and (d) of this section.

9 school district, a regional educational attendance area, or the University of Alaska;

10 (2) "school employer" means a municipal school district, a regional

 9 employees of other participating governmental units, or persons entitled to coverage
 10 under AS 23.15.136, subject to the following conditions:

11 (1) a group insurance policy shall provide one or more of the following
 12 benefits: life insurance, accidental death and dismemberment insurance, weekly
 13 indemnity insurance, hospital expense insurance, surgical expense insurance, dental
 14 expense insurance, audiovisual insurance, or other medical care insurance;

15 (2) each eligible employee of the state **or other participating**
 16 **governmental unit and** [,] the spouse and the unmarried children chiefly dependent
 17 on the eligible employee for support [, AND EACH ELIGIBLE EMPLOYEE OF

 26 secs. 1 - 3 and 5 - 11 of this Act.

27 * **Sec. 14.** The uncodified law of the State of Alaska is amended by adding a new section to
 28 read:

29 **TRANSITION.** Not later than 30 days after enrolling in a health care plan
 30 administered by the state under AS 39.30.090 or 39.30.091, a governmental unit that, before
 31 the effective date of this section, maintains a self-funded insurance reserve for the purpose of

1 paying employee health insurance claims shall transfer the closing balance of that reserve to
2 the group health and life benefits fund under AS 39.30.095. An amount transferred under this
3 section by a governmental unit that is a school district shall be applied to offset
4 reimbursement owed by that school district under AS 14.27.010(d), enacted by sec. 3 of this
