4 (c) A charter school shall operate under a contract between the charter school  
5 and the local school board. A contract must contain the following provisions:

6 (1) a description of the educational program;

7 (2) specific levels of achievement for the education program;

8 (3) admission policies and procedures;

9 (4) administrative policies;

10 (5) a statement of the charter school's funding allocation from the  
11 local school board during the first three years of

12 (A) the charter school's operation; and

13 (B) an expansion of the range of grades the charter school  
14 serves;

15 (6) a statement of the charter school's funding allocation from the local  
16 school board and costs assignable to the charter school program budget that applies in  
17 circumstances other than those described in (5) of this subsection;

18 (7) [(6)] the method by which the charter school will account for  
19 receipts and expenditures;

20 (8) [(7)] the location and description of the facility;

21 (9) [(8)] the name of the teacher, or teachers, who, by agreement  
22 between the charter school and the teacher, will teach in the charter school;

23 (10) [(9)] the teacher-to-student ratio;

- 2                   (12) [(11)] the term of the contract, not to exceed a term of 10 years;
- 3                   (13) [(12)] a termination clause providing that the contract may be

- 6 cause;
- 7                   (14) [(13)] a statement that the charter school will comply with all state
- 8 and federal requirements for receipt and use of public money;
- 9                   (15) [(14)] other requirements or exemptions agreed on [UPON] by the
- 10 charter school and the local school board."
