6 ** Sec. 13. AS 14.14 is amended by adding a new section to read:

7 **Sec. 14.14.040. School district budget.** Each school district shall, not later
8 than July 15 of each year,

9 (1) submit the district's budget for the current fiscal year to the
10 department;

11 (2) publish a certified copy of the budget prominently on the district's
12 publicly available Internet website; the budget must be accessible through a link on the
13 district's Internet website home page; and

14 (3) post a certified copy of the budget in a conspicuous, publicly
15 accessible place at the principal administrative office of the district.

16 * Sec. 14. AS 14.14.050(a) is amended to read:

17 (a) The school board in each school district shall, before October 1 of each
18 year, provide for an audit of all school accounts for the school year ending the
19 preceding June 30. To make the audit the school board shall contract with a public
20 accountant who has no personal interest, direct or indirect, in the fiscal affairs of the
21 district. A [ONE] certified copy of the audit shall be filed with the commissioner
22 [AND ONE CERTIFIED COPY SHALL BE POSTED IN A PUBLIC PLACE AT
23 THE PRINCIPAL ADMINISTRATIVE OFFICE OF THE DISTRICT].

1 * **Sec. 15.** AS 14.14.050(b) is amended to read:

2 (b) The audit shall conform in form to requirements established by the
3 commissioner. The commissioner shall withhold all payments of state funds after
4 November 15 to a school district that fails to satisfy the requirements of this section
5 and AS 14.14.040 [FILE A CERTIFIED COPY OF THE AUDIT WITH THE
6 DEPARTMENT].

7 * **Sec. 16.** AS 14.14.050 is amended by adding a new subsection to read:

8 (e) Each school district shall, not later than November 15 of each year,

9 (1) publish a certified copy of the audit prominently on the district's
10 publicly available Internet website; the audit must be accessible through a link on the
11 district's Internet website home page; and

12 (2) post a certified copy of the audit in a conspicuous, publicly
13 accessible place at the principal administrative office of the district."
