5 and the local school board. A contract must contain the following provisions:

7 (2) specific levels of achievement for the education program;

8 (3) admission policies and procedures;

9 (4) administrative policies;

10 (5) a statement of the charter school's funding allocation from the
11 local school board during the first two years of

12 (A) the charter school's operation; and

13 (B) an expansion of the range of grades the charter school
14 serves;

15 (6) a statement of the charter school's funding allocation from the local
16 school board and costs assignable to the charter school program budget that applies in
17 circumstances other than those described in (5) of this subsection;

18 (7) [(6)] the method by which the charter school will account for
19 receipts and expenditures;

20 (8) [(7)] the location and description of the facility;

21 (9) [(8)] the name of the teacher, or teachers, who, by agreement
22 between the charter school and the teacher, will teach in the charter school;

23 (10) [(9)] the teacher-to-student ratio;

1 **(11)** [(10)] the number of students served;
 2 **(12)** [(11)] the term of the contract, not to exceed a term of 10 years;
 3 **(13)** [(12)] a termination clause providing that the contract may be
 4 terminated by the local school board for the failure of the charter school to meet
 5 educational achievement goals or fiscal management standards, or for other good
 6 cause;

7 **(14) a clause providing that, before a local school board terminates**
 8 **a contract, the local school board must provide the charter school with written**
 9 **notice and a reasonable opportunity, as determined by the local school board, to**
 10 **cure the problem;**

11 **(15)** [(13)] a statement that the charter school will comply with all state
 12 and federal requirements for receipt and use of public money;

13 **(16)** [(14)] other requirements or exemptions agreed on [UPON] by the
 14 charter school and the local school board."

 25 must, at a minimum, equal the greater of

26 (1) the amount of the funding allocation stated in the contract between
 27 the charter school and the local school board for the operation or expansion, as
 28 required by AS 14.03.255(c)(5); or

29 (2) the amount calculated under (a) of this section."
