3 **\*\* Sec. 24.** AS 15.20.203(b) is amended to read:

4 (b) An absentee ballot may not be counted if

5 (1) the voter has failed to properly execute the certificate;

6 (2) an official or the witnesses authorized by law to attest the voter's  
7 certificate fail to execute the certificate, except that an absentee ballot cast in person  
8 and accepted by an absentee voting official or election supervisor may be counted  
9 despite failure of the absentee voting official or election supervisor to properly sign  
10 and date the voter's certificate as attesting official as required under AS 15.20.061(c);

11 (3) the ballot is not attested on or before the date of the election;

12 (4) the ballot, if postmarked, is not postmarked on or before the date of  
13 the election;

14 (5) after the day of election, the ballot was delivered by a means other  
15 than mail; or

16 (6) the voter voted

17 (A) in person and is a

18 (i) first-time voter who initially registered by mail or by  
19 facsimile or other electronic transmission approved by the director  
20 under AS 15.07.050, has not provided the identification required by  
21 AS 15.15.225(a), was not eligible for waiver of the identification  
22 requirement under AS 15.15.225(b), and has not provided the  
23 identifiers required in AS 15.07.060(a)(2) and (3) that can be verified

1 through state agency records described in AS 15.07.055(e); or

2 (ii) voter other than one described in (i) of this  
3 subparagraph, did not provide identification described in  
4 AS 15.15.225(a), was not personally known by the election official,  
5 and has not provided the identifiers required in AS 15.07.060(a)(2) and  
6 (3); or

7 (B) by mail or electronic transmission, is a first-time voter who  
8 initially registered by mail or by facsimile or other electronic transmission  
9 approved by the director under AS 15.07.050 to vote, has not met the  
10 identification requirements set out in AS 15.07.060, and does not submit with  
11 the ballot a copy of a

12 (i) driver's license, state identification card, current and  
13 valid photo identification, birth certificate, passport, or identification  
14 card issued by a federally recognized tribe [HUNTING OR  
15 FISHING LICENSE; OR

16 (ii) CURRENT UTILITY BILL, BANK  
17 STATEMENT, PAYCHECK, GOVERNMENT CHECK, OR OTHER  
18 GOVERNMENT DOCUMENT; AN ITEM DESCRIBED IN THIS  
19 SUB-SUBPARAGRAPH MUST SHOW THE NAME AND  
20 CURRENT ADDRESS OF THE VOTER]."
