**FOR AN ACT ENTITLED**

1 **"An Act making appropriations, including supplemental appropriations, capital**  
2 **appropriations, reappropriations, and other appropriations; amending appropriations;**  
3 **capitalizing funds; making appropriations under art. IX, sec. 17(c), Constitution of the**  
4 **State of Alaska, from the constitutional budget reserve fund; and providing for an**  
5 **effective date."**

6 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**
