A RESOLUTION

1 **Urging the federal government to waive the new H-1B Visa fees for teachers in the state.**

2 **BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

3 **WHEREAS** many school districts in the state, particularly those located in rural and
4 remote communities, face persistent shortages of qualified educators, especially in critical
5 subject areas, including math, science, and special education, which creates significant
6 challenges to maintaining consistent and high-quality instruction; and

7 **WHEREAS** a growing number of school districts in the state have hired international
8 educators through the H-1B visa process to address shortages and expand workforce capacity;
9 and

10 **WHEREAS** a 2025 executive order raised the cost of H-1B visas to \$100,000 a
11 person each year, which threatens to impose significant financial hurdles for schools and
12 employers in the state; and

13 **WHEREAS**, currently, the state employs close to 500 international educators working
14 in schools on visas; and

15 **WHEREAS** implementation of the 2025 executive order could result in the state
16 facing the difficult choice of paying millions of dollars for visa recipients or going without

1 these needed teachers; and

2 **WHEREAS**, already, more than 5,000 state students began this school year without a
3 teacher, undermining their right to a properly maintained education system; and

4 **WHEREAS** time is of the essence, as state school districts must begin hiring now to
5 secure educators in time for the fall school year; and

6 **WHEREAS** the state is committed to providing students with a high-quality
7 education, ensuring each student has the opportunity to succeed academically and reach their
8 full potential; and

9 **WHEREAS** recruitment and retention of qualified educators is essential to the success
10 of the state's educational institutions and the long-term sustainability and well-being of our
11 communities and economy;

12 **BE IT RESOLVED** that the Alaska State Legislature urges the federal government to
13 waive the \$100,000 H-1B visa fee for individuals being hired as educators in the state.

19 Honorable Nicholas Begich, U.S. Representative, members of the Alaska delegation in
20 Congress.
