FISCAL NOTE ANALYSIS

STATE OF ALASKA
2025 LEGISLATIVE SESSION

Analysis

This legislation amends a reporting requirement for the Office of Procurement and Property Management, and creates the Office of Entrepreneurship (OOE) in the Department of Commerce, Community, and Economic Development.

The OOE will be established as a new component in the Executive Administration and Development results delivery unit. The OOE is charged with promoting entrepreneurship in the state, as well as providing direct technical assistance to new businesses. Additionally, HB 30 adds a new section requiring state agencies to spend 5% of their appropriations for economic development programs for the benefit of new businesses in the state and to notify the OOE of those expenditures. Furthermore, the OOE is required to provide an annual report to the legislature detailing legislation enacted in the previous year that supports, hinders, or otherwise affects new businesses in the state.

The OOE will be led by a Division Director. One Program Coordinator will be tasked with providing assistance and coordination to connect organizations and new businesses. The Program Coordinator will work closely with a Research Analyst to analyze the impacts of new legislation on businesses and will collaboratively compile and prepare the annual report to the legislature.

The department does not currently have office space available for the OOE. New office space will need to be secured, estimated at 750 square feet at \$2.50 per square foot per month.

If this legislation passes, the following expenses will be incurred to establish and support the OOE:

Personal Services:

\$222.7	One full-time Division Director (range 27) located in Juneau.
\$139.8	One full-time Program Coordinator 2 (range 20) located in Juneau.
\$124.7	One full-time Research Analyst 3 (range 18) located in Juneau.

Travel:

\$ 6.0	Travel for three positions two times per year for in-state meetings and trainings needed to implement and comply with this legislation (\$2.0 / position / year).
\$ 15.0	Three out-of-state trips per year to attend trainings and conferences related to entrepreneurship and growth opportunities.

Services:

\$ 15.0	Department of Law regulations review in FY2026 only.
\$ 75.0	Statewide and allocated core services costs for three positions (\$25.0 / position / year).
\$ 22.5	Annual office space rental (\$2.50 / square foot / month).
\$ 5.0	Annual advertising costs (brochures, pamphlets, online marketing, etc.).

Commodities:

\$30.0	One-time set up costs for equipment and space for three positions in FY2026 only (\$10.0 / position).
\$ 6.0	Ongoing supply and equipment costs (\$2.0 / position / year).
