FISCAL NOTE ANALYSIS

STATE OF ALASKA
2026 LEGISLATIVE SESSION

Analysis

This bill creates two new felony level crimes for the possession and distribution of generated obscene child sexual abuse material. These crimes include increased penalty ranges for recidivist convictions and are listed as sex offenses.

The Agency is unable to effectively predict how many people would be charged under this statute and of those the number that would be appointed counsel. The agency cannot predict the extent of this impact and therefore submits a zero fiscal note at this time. The agency will continue to monitor the effects of this legislation and assess whether additional resources may be needed in the future.
