## FISCAL NOTE ANALYSIS

## Analysis

House Bill 49 raises the minimum legal age for purchasing and possessing tobacco, electronic smoking products, and products containing nicotine from 19 to 21. Sections 1-9.

Section 3, concerning possession of these products by those under 21, establishes that the offense is a violation with a fine of no more than \$300. This change to the age of those who may be cited for possession may result in more violations being filed with the court, but the number is not expected to be substantial. Section 4 includes a new provision stating that the supreme court will create a schedule to allow that fine to be paid without a court appearance *if the person is over 18*. Though this creates a task for the court system, the work involved will not require additional resources and can be absorbed by our staff without a fiscal impact.

Section 18 creates new AS 43.50.325 concerning restrictions on shipping tobacco products, and violation of that statute would be a new crime, classified as a class A misdemeanor. New AS 43.50.325(g). Similarly, section 19 creates a new class A misdemeanor for violating restrictions on shipping electronic smoking products (new AS 43.50.880(g)). The court system can respond to any criminal cases filed for these offenses without fiscal impact.

The court system therefore submits this zero fiscal note.
