FISCAL NOTE ANALYSIS

2026 LEGISLATIVE SESSION**Analysis**

HB 52 requires the Department of Health to submit an annual report to the legislature. However, the report must include data provided by the Department of Family and Community Services regarding children in foster care who are placed in psychiatric hospitals. This data is currently tracked by the department.

The Department of Family and Community Services, Office of Children's Services, does not anticipate any additional costs associated with providing this required data; therefore, a zero fiscal note is submitted. However, the department may lack statutory authority to collect data on minors who are not in its custody for reporting purposes.
