FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2025 LEGISLATIVE SESSION

**Analysis**

This bill enhances procurement preferences for the state, municipalities, and school districts for agricultural and fisheries products harvested or processed within Alaska. It raises the percentage above similar outside products where the state or municipality shall purchase Alaska-produced products from 7 percent to 10 percent and raises the percentage above where the state or municipality may purchase Alaska-produced products from 15 percent to 25 percent.

The proposed bill changes thresholds in existing processes and doesn't require additional reviews and only requires updated guidance.

There is no anticipated fiscal impact to the department, therefore, a zero fiscal note is submitted.
