FISCAL NOTE ANALYSIS

2025 LEGISLATIVE SESSION

**Analysis**

This legislation allows the Department of Revenue to file permanent fund dividend (PFD) applications for individuals in arrears under a child support order and then garnish those funds. PFD garnishments for child support are prioritized before Unemployment Insurance garnishments. Therefore, this legislation does not impact the Department of Labor and Workforce Development Unemployment Insurance program.
