FISCAL NOTE ANALYSIS

STATE OF ALASKA
2025 LEGISLATIVE SESSION

Analysis

This bill reclassifies the failure to report a violent crime against an adult under AS 11.56.767 from a violation to a class B misdemeanor. A person convicted of a violation, generally, only faces a possible fine. However, a person convicted of a class B misdemeanor may be sentenced to a term of imprisonment of up to 90 days as well as any associated fines. Additionally, the Criminal Division typically does not handle violations, but would handle cases where the offense is classified as a crime. Therefore, it is expected that the Criminal Division will see additional case referrals should this bill become law.

The Criminal Division is unable to assess how many additional cases would be referred as a result of this bill and, therefore, submits a zero fiscal note at this time. However, the division will continue to monitor the impacts of this bill and assess whether additional resources may be needed in the future.
