FISCAL NOTE ANALYSIS

STATE OF ALASKA
2026 LEGISLATIVE SESSION**Analysis**

This legislation will require the Alaska Board of Barbers and Hairdressers to authorize the Division of Corporations, Business and Professional Licensing to issue licenses and permits to practice and for schools of barbering, hairdressing, manicuring, and esthetics. The board will still be the only entity with the authority to deny such licenses. This bill clarifies the authority for the board and the division to maintain the status quo for issuances of licenses for this program.

The Division of Corporations, Business and Professional Licensing does not anticipate fiscal impact from this legislation.

Professional licensing programs within the Division of Corporations, Business and Professional Licensing are funded by Receipt Supported Services, fund source 1156 Rcpt Svcs (DGF). Per AS 08.01.065, licensing fees for each occupation are set so the total amount of revenue collected approximately equals the occupation's actual regulatory costs.
