**FISCAL NOTE ANALYSIS****STATE OF ALASKA  
2026 LEGISLATIVE SESSION****Analysis**

This bill would allow the recipient of a drawing hunt permit to transfer the permit to another person, with or without monetary compensation. The permit holder must first notify the Alaska Department of Fish and Game (ADF&G) of the transfer before it occurs, including the name and hunting license number of the recipient and any other identifying information required by ADF&G. Upon receiving notification of a transfer, ADF&G staff would reassign the permit to the new recipient in the drawing hunt permit system.

The bill authorizes the Commissioner of Fish and Game to adopt regulations necessary to implement the new provisions, including establishing a fee for registering permit transfers or reissuances to mitigate administrative costs associated with staff time to process transfers. If a fee is established, the revenue would be deposited into the Fish and Game Fund. Since the fee amount, if any, is unknown, and the potential increase in drawing hunt permit applications it is difficult to estimate at this time, the change in revenue is indeterminate.

Depending on the volume of transfer requests, it is possible an additional position would be needed. However, this is also difficult to assess at this time. Assuming a fee is established, ADF&G could request a position funded through Fish and Game Fund revenue generated from the fees if determined necessary later. Accordingly, there are no costs to the department reflected in this fiscal note.
