FISCAL NOTE ANALYSIS

Analysis**Background and Summary**

This bill adds language allowing a pilot who flies out of Alaska on a United States airline certified as an air carrier by the Federal Aviation Administration (FAA) to remain eligible for the Permanent Fund Dividend (PFD), provided they meet all other eligibility requirements.

After discussions with the bill sponsor, the division has reduced its assumption that all 4,500 pilots would fall into this category. The division now assumes roughly half of the total would qualify and therefore a new position would not be necessary. Should this bill become law, the division will track the impact and total pilots who apply under this exemption. Should the workload increase beyond what is currently projected and what the division staff can absorb, a budget request may be submitted to handle the additional work. Therefore, an indeterminate fiscal note is submitted at this time.

Revenue Impact

There are no changes in revenues as a result of the proposed legislation.

Costs

There will be one-time programming costs to add the allowable absence to the PFD application which the division is unable to estimate at this time.
