FISCAL NOTE ANALYSIS

STATE OF ALASKA
2026 LEGISLATIVE SESSION**Analysis**

HB 298 amends provisions of the Legislative Ethics Act, including changes to the authority and operations of the Select Committee on Legislative Ethics (Committee) and revisions to procedures governing ethics complaints and committee proceedings.

The only direct fiscal impact identified relates to public members of the Committee. The bill changes the statutory reference for per diem and travel reimbursement from AS 24.60.130(f) to AS 24.10.130(c). This does not materially change the type of compensation provided, and any difference in cost is expected to be minimal.

While the bill makes structural and procedural changes to committee operations, including investigation and hearing processes, any resulting increase in workload is expected to be absorbed within existing staff and budget resources.

Overall, the fiscal impact of the legislation is anticipated to be negligible and can be absorbed within the current budget.
