Analysis

SB12 amends Alaska's permanent fund dividend statutes, allowing for individuals who are owed child support to apply for a dividend on behalf of the individual who owes them support. Additionally, the bill requires the Alaska Child Support Services Agency to provide a list of individuals who are in arrears on support payments to the Department of Revenue each year, and for the Department of Revenue to file a permanent fund dividend application for each of those individuals, if an application was not received. The bill adds protections from garnishment of dividends that were applied for on behalf of an individual owing child support and prioritizes distribution of these dividends to the individual(s) owed child support.

Under AS 47.12.155(c), the Department of Family and Community Services- Division of Juvenile Justice may seek garnishment of a parent's permanent fund dividend to pay for a parent's court ordered treatment. Given the exceptional rarity of the scenarios that would result in such a garnishment, no programmatic or fiscal impacts are anticipated.
