FISCAL NOTE ANALYSIS

STATE OF ALASKA
2025 LEGISLATIVE SESSION**Analysis**

This bill would count a permanent fund dividend applied for and claimed by an individual owed child support under AS 43.23.005(i) or distributed to an individual owed child support under AS 43.23.005(j) is counted as a child support payment.

This bill requires the Child Support Enforcement Division (CSED) to provide the Permanent Fund Dividend Division (PFDD) with a list of individuals in arrears under a child support order between January 1 and March 31 of each year. CSED can provide the list of individuals in arrears under a child support order to the PFD Division.

This bill would allow an individual to file on behalf of another adult that owes child support. It also allows the Department to file on behalf of said adult. Removing the signing of application for eligibility determination, and allows the individual owed child support to submit residency evidence.

Individuals owed child support under this statute may not use these funds to make contributions, may not donate any amount of their dividend under this section, and these applications are separate from regularly filed apps.

The Department of Family and Community Services, the Alaska Commission on Post Secondary Education, the Department of Health, the Department of Labor and Workforce Development, and the University of Alaska may not claim a PFD filed under this section.

This bill will require further study to determine costs for additional personnel, printing and postage, and programming costs to make these changes.
