FISCAL NOTE ANALYSIS

STATE OF ALASKA
2025 LEGISLATIVE SESSION

Analysis

This bill Creates a new Class A felony for organized theft for those who participate in a coordinated effort to commit theft in the first degree (class B felony) and theft in the second degree (class C felony) with groups of three or more persons, repeatedly. Additionally, this bill expands theft in the second degree to include theft of medical records and information and expands theft in the third degree to include theft of mail.

New crimes generally result in additional workload for the Office of Public Advocacy and though the Agency is unable to absorb significant workload increases the agency does not anticipate a significant increase in appointments based on this legislation and submits a zero fiscal note accordingly.
