## FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2026 LEGISLATIVE SESSION**Analysis**

This legislation would allow the Department of Labor and Workforce Development (DOLWD) to share information with the University of Alaska (UA) for program evaluation and improvement, educational outreach, or public policy research. It requires a written agreement between UA and DOLWD to ensure the data is handled in compliance with state and federal requirements.

UA will need to cover any costs associated with the sharing of data because the federal grant that supports the Unemployment Insurance (UI) program under which this data is gathered cannot be used for costs associated with disclosures. Until DOLWD has entered into an agreement with UA on the type of data to be shared and the frequency of that sharing, DOLWD cannot say exactly how much this will cost. Based on similar agreements with other state agencies, this could cost from \$1,300 to \$46,500.

The department has sufficient interagency receipt authority in its budget to cover the cost of this new agreement if it falls within that range.
