FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2026 LEGISLATIVE SESSION

Analysis

This bill amends AS 14.33.220(b) by expanding required reporting entities by adding Child Advocacy Centers. School employees, students, and volunteers report instances of harassment, intimidation, or bullying to both an appropriate school official and a Child Advocacy Center.

To AS 14.33, providing guidance on parental notification of incidents of harassment, intimidation, or bullying; and adds section 44.41.080. Firearm safe storage grant fund. To AS 44.41, establishing a grant fund in the Department of Public Safety to support purchase of firearm safe storage devices for parents and families to request in instances where lethal medications and firearms need to be stored in the home due to a concern for a student’s safety.

DEED would update regulations, policy, resources, and training to support implementation.
