Pursuant to adjournment the House was called to order by Speaker Edgmon at 10:43 a.m.

Roll call showed 39 members present. Representative Nelson had been excused from a call of the House today.

The invocation was offered by the Chaplain, Reverend Nancy Campbell of White Fields Church. Representative Story moved and asked unanimous consent that the invocation be spread on the journal. There being no objection, it was so ordered.
