Pursuant to adjournment the House was called to order by Speaker Edgmon at 11:13 a.m.

Today, as so many in the world are reeling from pain and suffering by evil regimes, yet simultaneously we are seeing miracles and wonders of biblical proportions, providing supernatural protection, resilience, and survival. Briefly, they include the requirements to honor the creator, respect the sanctity and the dignity of each life, reject violence, act honestly, value family, promote generosity, and build a just and moral society. In that vein, our wonderful state, with the support of our government, has embarked on a very important project: The Alaska Friendship Circle – the first Inclusive Early Childhood Play Center in Alaska, for children with disabilities and special needs, founded on the belief that within each person is a soul, and that soul is equal and worthy of boundless love and connection.

Almighty G-d, bless the members of the Alaska State House assembled here today, to fulfil one of your seven commandments, which is to govern by just laws. May we all be graced by the merit of the global spiritual giant and leader, your servant, the Lubavitcher Rebbe, Rabbi Menachem M. Schneerson, whose 124th birthday will be celebrated on the 11th day of the Hebrew month of Nissan, Sunday, March 29, four days before Passover.

**SB 95**

The following memorandum dated March 11, 2026, from Hilary V. Martin, Revisor of Statutes, was received:

"Section 35, ch. 14, SLA 2025, directed the Department of Health to "amend and submit for federal approval the state plan for the state's child care assistance program under the federal child care and development fund program, consistent with AS 47.25.001(a), as amended by sec. 6 . . . ." Under sec. 37(a), ch. 14, SLA 2025:

Section 6 of this Act takes effect only if, on or before January 1, 2026, the United States Department of Health and Human Services

(1) approves the amendment to the state plan for the child care assistance program under the federal child care and development fund program, consistent with AS 47.25.001(a), as amended by sec. 6 of this Act; or

(2) determines that approval of the amendment to the state plan for the child care assistance program is not necessary.

Section 38 provides that if sec. 6 takes effect, it takes effect "on the day after the date the United States Department of Health and Human Services approves the corresponding amendment to the state plan or determines that approval is not necessary." I received notice from the commissioner of health on November 4, 2025, that the United States Health and Human Services, Administration for Children and Families, Office of Child Care, determined that an amendment to the state plan for the child care assistance program was not necessary on September 17, 2025. Therefore, sec. 6, ch. 14, SLA 2025, took effect on September 18, 2025.

Please publish this in the journal to provide notice that the condition has been satisfied."
