Pursuant to adjournment the Senate was called to order by President Stevens at 11:04 a.m.

The roll showed nineteen members present. Senator Olson was absent.

The prayer was offered by the Chaplain, Father Patrick Casey, Co-Cathedral of the Nativity of the Blessed Virgin Mary. Senator Hoffman moved and asked unanimous consent the prayer be spread. Without objection, it was so ordered.
