Pursuant to adjournment the Senate was called to order by President Stevens at 10:46 a.m.

The roll showed nineteen members present. Senator Stedman was absent.

The prayer was offered by the Chaplain, Nova Tomaszewski, Senate Page. Senator Hoffman moved and asked unanimous consent the prayer be spread. Without objection, it was so ordered.

Senator Lisa Murkowski was escorted to the rostrum and welcomed by President Stevens and Speaker Edgmon.

U.S. Senator Lisa Murkowski delivered her address. This address appears in Senate and House Joint Journal Supplement No. 6.

Following her address, there was a question and answer period. Senator Murkowski received a standing ovation.

Senator Giessel moved and asked unanimous consent the Joint Session stand in adjournment. Without objection, President Stevens adjourned the Joint Session at 12:31 p.m.
