IN THE LEGISLATURE OF THE TERRITORY OF ALASKA  
TWENTY-FIRST SESSION  
A BILL

For an Act entitled: "An Act relating to Old Age Assistance,  
increasing maximum benefits thereunder,  
and amending Sec. 51-2-51 AOLA 1949, as  
amended by Chapter 35 SLA 1949, as  
amended by Chapter 49 SLA 1951.

BE IT ENACTED BY THE LEGISLATURE OF THE TERRITORY OF ALASKA:

Section 1. That Sec. 51-2-51 AOLA 1949, as amended by  
Ch. 35 S.L.A. 1949, as amended by Ch. 49 S.L.A. 1951, is  
hereby amended to read as follows:

Sec. 51-2-51. PERSONS ENTITLED TO ASSISTANCE:-  
LIMITATION OF AMOUNT. Financial assistance, so far as  
practicable under the conditions in this Territory, shall  
be given under this Act to any aged, needy resident of the  
Territory who is a citizen of the United States and who has  
resided in the Territory for five (5) years during the nine  
(9) years immediately preceding the date of application,  
who has attained the age of 65 years and who has not made a  
voluntary assignment or transfer of property for the  
purpose of qualifying for such assistance. Such assistance  
granted shall be in such amount as will provide the appli-  
cant with a reasonable subsistence compatible with  
decency and health, but shall in no case exceed the rate  
of (\$80.00) \$100.00 per calendar month, provided, that if  
any person given an allowance under the provisions hereof

1 shall apply for admittance to and shall be admitted to  
2 the Alaska Pioneers' Home or any public institution, any  
3 allowance granted hereunder shall be suspended during the  
4 time such person shall be an inmate of the Home or any  
5 other public institution, and any inmate of the Home or  
6 other public institution, who is eligible to receive an  
7 allowance under the provisions hereof may at any time  
8 make application for such allowance in lieu of the  
9 support and maintenance provided for him or her in such  
10 Home or other public institution.
