HOUSE BILL NO. 14

IN THE LEGISLATURE OF THE TERRITORY OF ALASKA

TWENTY-FIRST SESSION

A BILL

For an Act entitled: "An Act pertaining to teacher's and superintendent's salaries; amending Secs. 37-6-1 and 37-6-2 ACLA 1949, as amended by Chapter 69 S.L.A. 1949, as amended by Chapter 104 S.L.A. 1951, and establishing an effective date."

BE IT ENACTED BY THE LEGISLATURE OF THE TERRITORY OF ALASKA:

Section 1. Sec. 37-6-1 ACLA 1949, as amended by Section 1, Chapter 69 S.L.A. 1949, as amended by Section 1, Chapter 104 S.L.A. 1951, is hereby amended to read as follows:

Sec. 37-6-1. Teacher's Salary Ranges by Divisions.

The Territorial Board of Education and school boards of school districts in the Territory of Alaska shall pay teachers regularly qualified in accordance with the Rules and Regulations of the Territorial Board of Education and employed by them within the following salary ranges: For the First Division, (\$3,600.00 TO \$5,000.00;) \$4,600.00 to \$6,000.00; Third Division, (\$3,940.00 TO \$5,340.00;) \$4,940.00 to \$6,340.00; Second and Fourth Divisions, (\$4,200.00 TO \$5,600.00.) \$5,200.00 to \$6,600.00.

Section 2. Sec. 37-6-2 ACLA 1949, as amended by Section 2, Chapter 69 S.L.A. 1949, as amended by Section 2, Chapter 104 S.L.A. 1951 is hereby amended to read as follows:

Sec. 37-6-2. Superintendent's Salary Ranges By

1 Divisions. The Territorial Board of Education and school
2 Boards of school districts in the Territory of Alaska shall
3 pay superintendents regularly qualified in accordance with
4 the Rules and Regulations of the Territorial Board and
5 employed by them within the following salary ranges: For
6 the First Division, (\$4,270.00 TO \$6,375.00;) \$5,270.00 to
7 \$7,375.00; Third Division, (\$4,670.00 TO \$6,775.00;) \$5,670.00 to
8 \$7,775.00; Second and Fourth Divisions,
9 (\$4,970.00 TO \$7,075.00.) \$5,970.00 to \$8,075.00.

10 Section 3. This Act shall become effective July 1, 1953.
