5 A BILL

6 For an Act entitled: "An Act to amend Section 51-5-2 (d) ACLA
7 1949 as amended by Chapter 25 SLA 1949,
8 and as further amended by Chapter 10 SLA
9 1951, providing for dependents' allowances
10 under the provisions of the Alaska
11 Employment Security Law; and to provide
12 for an effective date."

13 BE IT ENACTED BY THE LEGISLATURE OF THE TERRITORY OF ALASKA:

14 Section 1. That Sec. 51-5-2 (d) ACLA 1949 as amended by
15 Chapter 25 SLA 1949, by the addition of paragraph (4) and as
16 further amended by Chapter 10 SLA 1951, is hereby amended to
17 read as follows:

18 Sec. 51-5-2 (d) (4) "Dependency Allowances." Each
19 individual who is eligible to receive benefits for unemploy-
20 ment with respect to any week shall be paid with respect to
21 such week a dependency allowance of (20%) twenty-five per
22 centum of his weekly benefit amount for each of such
23 individual dependents who were being wholly or mainly
24 supported by such individual, but in no event shall such
25 allowance exceed (60% OF) the weekly benefit amount of such
26 individual, except where the amount of dependency allowance
27 is not a multiple of one dollar, in which case it shall be
28 computed to the next higher multiple of one dollar.
29 Dependency allowances shall be in addition to the unemploy-

1 ment benefits otherwise payable and shall not be considered
2 part of an individual's weekly benefit amount. The max-
3 imum potential benefits in a benefit year shall be increased
4 for claimants with dependent's allowances by the amount of
5 such allowances. No dependency allowance shall be payable
6 with respect to any week unless an unemployment benefit is
7 also payable with respect to such week. If both husband
8 and wife receive benefits with respect to a week of unemploy-
9 ment, neither shall be considered a dependent of the other
10 and only one of them shall be entitled to dependency
11 allowance with respect to dependents. (DEPENDENCY
12 ALLOWANCES SHALL BE EFFECTIVE WITH THOSE CLAIMANTS WHOSE
13 BENEFIT YEARS BEGIN ON OR AFTER JULY 1, 1949.)

14 Section 2. The provisions of this amendment shall become
15 effective with those claimants whose benefit year begins on or
16 after July 1, 1953.
