6 For an Act entitled: "An Act relating to salaries of Territorial
7 officers and employees; and fixing an
8 ~~effective date~~"

9 BE IT ENACTED BY THE LEGISLATURE OF THE TERRITORY OF ALASKA:

10 Section 1. Notwithstanding other laws, including those
11 fixing salaries of Territorial officers and employees and those
12 authorizing offices, boards, commissions, departments and other
13 agencies of the Territory to fix salaries for such officers and
14 employees, which may be inconsistent with the provisions of this
15 Act, the following schedule of salaries shall govern exclusively,
16 shall supersede all salaries heretofore established, by law or
17 otherwise, and shall constitute compensation in full of the
18 Territorial officers and employees designated below for the
19 performance by them of the duties incident to their respective
20 offices and for such other duties as are now or as may hereafter
21 be assigned to them:

28 Section 2. The salaries specified in Section 1 of this Act
29 for all deputies, assistants and others not heads or directors of

1 offices shall constitute maximum rates of compensation, but shall
2 in no way be interpreted as curtailing the authority and
3 discretion of the head or other governing or supervising
4 authority of the respective office, board, commission, department
5 or other agency to fix the salaries of such persons at rates less
6 than the maximums provided in that section.
