6 For an Act entitled: "An Act to repeal Chapter 133, Session
7 Laws of Alaska 1951, relating to the
8 organization of the Territorial government
9 of Alaska, and officially cited as the
10 "Governmental Reorganization of the
11 Twentieth Legislature"; reenacting Secs.
12 4-3-13, 7-1-2, 7-1-3, 7-1-4, 7-1-5,
13 7-1-6(b), 8-1-1, 8-1-2, 8-1-3, 8-1-4,
14 8-1-7, 8-1-9, 8-1-11, 8-1-13, 8-1-14,
15 8-1-15, 8-1-16, 8-1-17, 10-1-3, 10-1-4,
16 10-2-1, 10-2-2, 12-2-1, 12-3-3, 12-4-1,
17 13-1-1, 13-1-4, 15-1-1, 15-1-2, 15-1-3,
18 15-1-4, 43-3-36, ACLA 1949; reenacting

21 and declaring an emergency."

22 BE IT ENACTED BY THE LEGISLATURE OF THE TERRITORY OF ALASKA:

23 Section 1. Chapter 133, Session Laws of Alaska 1951, an
24 Act officially cited as the "Governmental Reorganization of the
25 Twentieth Legislature", is hereby repealed.

26 Section 2. Sections 4-3-13, 7-1-2, 7-1-3, 7-1-4, 7-1-5,
27 7-1-6(b), 8-1-1, 8-1-2, 8-1-3, 8-1-4, 8-1-7, 8-1-9, 8-1-11,
28 8-1-13, 8-1-14, 8-1-15, 8-1-16, 8-1-17, 10-1-3, 10-1-4, 10-2-1,
29 10-2-2, 12-2-1, 12-3-3, 12-4-1, 13-1-1, 13-1-4, 15-1-1, 15-1-2,

1 15-1-3, 15-1-4, and 43-3-36 ACLA 1949, are hereby reenacted to
2 read as they are printed in the Alaska Compiled Laws Annotated
3 1949; and Section 12-4-2 ACLA 1949, as amended by Chapter 101,
4 Session Laws of Alaska 1949, is hereby reenacted to read as it
5 is printed in Chapter 101, Session Laws of Alaska 1949.

6 Section 3. An emergency is hereby declared to exist and
7 this Act shall take effect immediately upon its passage and
8 approval.
