6 For an Act entitled: "An Act pertaining to teachers' and  
7 superintendents' salaries; amending  
8 Sections 37-6-1 and 37-6-2 ACLA 1949, as  
9 last amended by Chapter 104, Session Laws  
10 of Alaska 1951; and establishing an  
11 effective date."

12 BE IT ENACTED BY THE LEGISLATURE OF THE TERRITORY OF ALASKA:

13 Section 1. Section 37-6-1 ACLA 1949, as last amended by  
14 Chapter 104, Session Laws of Alaska 1951, is hereby amended to  
15 read as follows:

16 Section 37-6-1. TEACHERS' SALARY RANGES BY DIVISIONS.

17 The Territorial Board of Education and school boards of  
18 school districts in the Territory of Alaska shall pay  
19 teachers regularly qualified in accordance with the Rules  
20 and Regulations of the Territorial Board of Education and  
21 employed by them a salary within the following salary  
22 ranges: For the First Division, (\$3,600.00 TO \$5,000.00)  
23 ~~\$4,400.00~~ <sup>4200.00</sup> to ~~\$5,800.00~~ <sup>5600.00</sup>; Third Division, (\$3,940.00 TO  
24 \$5,340.00) ~~\$4,740.00~~ <sup>4540.00</sup> to ~~\$6,140.00~~ <sup>5940.00</sup>; Second and Fourth  
25 Divisions, (\$4,200.00 TO \$5,600.00) ~~\$5,000.00~~ <sup>4800.00</sup> to ~~\$6,400.00~~ <sup>6200.00</sup>.

26 Section 2. Section 37-6-2 ACLA 1949, as last amended by  
27 Chapter 104, Session Laws of Alaska 1951, is hereby amended to  
28 read as follows:

The Territorial Board of Education and school boards of school districts in the Territory of Alaska shall pay superintendents, regularly qualified in accordance with the Rules and Regulations of the Territorial Board and employed by them a salary within the following salary ranges: For the First Division, (<sup>4,270.00</sup> ~~\$4,270.00~~ TO <sup>6,375.00</sup> ~~\$6,375.00~~) ~~\$5,070.00~~ to ~~\$7,175.00~~; Third Division, (<sup>4,670.00</sup> ~~\$4,670.00~~ TO <sup>6,775.00</sup> ~~\$6,775.00~~) ~~\$5,470.00~~ to ~~\$7,575.00~~; Second and Fourth Divisions, (<sup>4,970.00</sup> ~~\$4,970.00~~ TO <sup>7,075.00</sup> ~~\$7,075.00~~) ~~\$5,770.00~~ to ~~\$7,875.00~~.
