6 For an Act entitled: "An Act to define prostitution, ^{lewdness} lewdness
7 and assignation; making all acts aiding or
8 abetting ^{with} these practices illegal; pro-
9 viding penalties therefor, ~~and declaring~~
10 ~~an emergency.~~"

11 BE IT ENACTED BY THE LEGISLATURE OF THE TERRITORY OF ALASKA:

12 Section 1. Definitions. The term "prostitution" includes
13 the giving or receiving of the body, ^{by a female} for sexual intercourse for
14 hire, ~~and~~ the giving or receiving of the body, ^{by a female} for indiscriminate
15 sexual intercourse; the term "lewdness" includes any indecent
16 or obscene act; and the term "assignation" includes the making
17 of any appointment or engagement for prostitution or lewdness,
18 or any act in furtherance of such appointment or engagement.]

19 Sec. 2. It is unlawful within the Territory of Alaska to
20 engage in prostitution, ~~lewdness~~, or assignation.]

21 Sec. 3. It is unlawful within the Territory of Alaska to
22 procure or to solicit, or to offer to procure or solicit for the
23 purpose of prostitution, ~~lewdness~~, or assignation.]

24 Sec. 4. It is unlawful within the Territory of Alaska ^{for any female} to ~~lewdness~~
25 receive or to offer or agree to receive any person into any
26 place, structure, building, boat, automobile, trailer, or any
27 other vehicle, for the purpose of prostitution, ~~lewdness~~, or
28 assignation,] or to permit any person there to remain for such
29 purpose, ~~or purposes.~~]

p. 1, lines 6 & 7: delete ", lewdness and assignation"

p. 1, line 8: Change "these" to "this" and delete "s" from word "practices"

p. 1, lines 9 & 10: delete words "; and declaring an emergency."
place period (.) after word "therefor" in line 9

p. 1, line 13: insert the words "by a female" between the words "body" and "for"

p. 1, line 14: insert the words "by a female" between the words "body" and "for".

p. 1, line 14: place period after "hire" and delete remainder of sentence

p. 1, lines 14 & 15: strike ", and the giving or receiving of the body for indiscriminate sexual intercourse;"

p. 1, line 17: place period after lewdness and strike balance of sentence.

p. 1, line 20: strike first comma, substitute period and delete remainder of line

p. 1, line 23: strike comma, substitute period and delete remainder of line

p. 1, line 24: after word "Alaska" insert word "for any female"

p. 1, line 27: after "Prostitution" delete remainder of line and word "assignation" on line 28

p. 1, line 29: Insert period after "purpose" and strike words "or purposes"

1 ~~Sec. 5.~~ It is unlawful within the Territory of Alaska to
2 direct, take or transport, or to offer, or agree to take or
3 transport, any person to any place, structure, building, boat,
4 automobile, trailer, or other vehicle, for the purpose of prosti-
5 tution, lewdness, or assignation.

6 ~~Sec. 6.~~ It is unlawful within the Territory of Alaska to
7 reside in, enter, or remain in any place, structure, or building,
8 or to enter and remain in any boat, automobile, trailer, or
9 other vehicle for the purpose of prostitution, lewdness, or
10 assignation.

11 ~~Sec. 7.~~ Any person convicted of violating any of the pro-
12 visions of this Act is guilty of a misdemeanor and shall be
13 fined a sum not exceeding \$500.00, or shall be imprisoned in
14 jail not exceeding ninety (90) days, or both.

15 ~~Sec. 8.~~ If any portion of this Act shall be declared
16 unconstitutional, such decision shall not affect the validity
17 of the remaining portions or sections of this Act.

18 ~~Sec. 9.~~ An emergency is hereby declared to exist, and this
19 Act shall take effect immediately upon its passage and approval.
