IN THE LEGISLATURE OF THE TERRITORY OF ALASKA

TWENTY SECOND SESSION

A BILL

For an Act entitled: "An Act to provide roadside rests <sup>and recreational facilities</sup> for <sup>and waterways</sup> travelers on highways in Alaska; and ~~making~~ an appropriation therefor."

BE IT ENACTED BY THE LEGISLATURE OF THE TERRITORY OF ALASKA:

Section 1. Selection of sites. The Highway Engineer and the Land Commissioner, jointly, shall select sites of 10 acres or less for their historic or scenic value, or for <sup>recreation beach along waterways,</sup> roadside rests for travelers resting, camping, or parking, and determine what facilities are necessary or desirable at such sites. Selection of the sites for roadside rests <sup>and recreation beaches</sup> shall be based upon the flow of traffic and distances to and between facilities otherwise provided. Insofar as possible, sites shall be located on, or adjacent to, <sup>and small boat waterways,</sup> highway rights-of-way, and the Land Commissioner shall have power to acquire the sites so jointly selected by grant, gift, purchase, lease, dedication or prescription and hold the same in the name of the Territory.

Section 2. Historic scenic sites, <sup>recreation beaches</sup> and roadside rests; facilities thereon. The Highway Engineer is hereby authorized <sup>recreation beaches</sup> to construct and maintain such facilities at scenic sites, or roadside rests as he may determine to be necessary and desirable. Such facilities may include but are not limited to, access roads, camp facilities (including picnic tables, fireplaces, and toilets), camping areas or other facilities deemed necessary and desirable for the convenience and benefit of

Section 3. Appropriation. There is hereby <sup>authorized to be</sup> appropriated  
for the purposes of this Act the sum of <sup>\$100,000</sup> \$100,000 out of any  
monies in the General Fund not otherwise appropriated, 75 per  
cent of which shall be expended by the Highway Engineer for  
development of sites and 25 per cent of which shall be ex-  
pended by the Land Commissioner for acquisition of sites and  
expenses incidental thereto. <sup>for</sup> This appropriation <sup>authorized herein</sup> shall con-  
tinue until expended.
