6 For an Act entitled: "An Act relating to the Aeronautics and  
7 Communications Commission; amending  
8 Section 32-3-2, ACLA, 1949, as amended."

9 BE IT ENACTED BY THE LEGISLATURE OF THE TERRITORY OF ALASKA:

10 Section 1: Section 32-3-2, Alaska Compiled Laws Annotated,  
11 1949, as amended by Section 1 of Chapter 9, Session Laws of  
12 Alaska, 1951, is hereby amended so as to read as follows:

13 Sec. 32-3-2. Aeronautics and Communications Commis-  
14 sion created: Members: Chairman. There is hereby created  
15 an Aeronautics and Communications Commission consisting of  
16 five ~~FOUR~~ persons to be appointed by the Governor subject  
17 to confirmation by the Legislature. ~~No more than two mem-~~  
18 bers ~~ONE MEMBER~~ of this Commission shall be chosen from  
19 any one ~~EACH OF THE FOUR~~ judicial division 3, and per-  
20 sons so chosen shall be resident in, and legally qualified  
21 voters in, the divisions from which they are chosen. Per-  
22 sons qualified to serve as members of this Commission shall  
23 be directly interested in the aviation business in the  
24 Territory. Members of the Aeronautics and Communications  
25 Commission, hereinafter referred to as the Commission,  
26 shall be appointed to serve for a period of four ~~TWO~~  
27 years, or until their successors are appointed and quali-  
28 fied. The Commission shall choose its own Chairman, and  
29 all members thereof shall serve as Commissioners without

p. 1, line 17: Strike all matter beginning with the word "No" down to and including the word "Territory" in line 24 and insert in lieu thereof the following: "One member shall be chosen from each judicial division and each person so chosen shall be directly interested in the aviation business in the division from which chosen. The fifth member shall be chosen at large from the Territory as a public member and shall have no direct interest in the aviation business. The public member shall be Chairman of the Commission."
