IN THE LEGISLATURE OF THE TERRITORY OF ALASKA

TWENTY-SECOND SESSION

A BILL

For an Act entitled: "An Act pertaining to teachers' and superintendents' salaries; amending Sections 37-6-1 and 37-6-2 ACLA 1949, as last amended by Chapter 104, Session Laws of Alaska 1953; and establishing an effective date."

BE IT ENACTED BY THE LEGISLATURE OF THE TERRITORY OF ALASKA:

Section 1. Section 37-6-1 ACLA 1949, as last amended by Chapter 104, Session Laws of Alaska 1953, is hereby amended to read as follows:

Section 37-6-1. TEACHERS' SALARY RANGES BY DIVISIONS.

The Territorial Board of Education and school boards of school districts in the Territory of Alaska shall pay teachers regularly qualified in accordance with the Rules and Regulations of the Territorial Board of Education and employed by them a salary within the following salary ranges: For the First Division, (\$4,200.00 to \$5,600.00) \$4,200.00 to \$6,870.00; Third Division, (\$4,540.00 to \$5,940.00) \$4,540.00 to \$7,210.00; Second and Fourth Divisions, (\$4,800.00 to \$6,200.00) \$4,800.00 to \$7,470.00.

Section 2. Section 37-6-2 ACLA 1949, as last amended by Chapter 104, Session Laws of Alaska, 1953, is hereby amended to read as follows:

Section 37-6-2. SUPERINTENDENTS' SALARY RANGES BY

3. pay superintendents, regularly qualified in accordance with  
4. the Rules and Regulations of the Territorial Board and  
5. employed by them a salary within the following salary  
6. ranges: For the First Division. (\$4,870.00 to \$6,975.00)  
7. \$4,870.00 to \$8,640.00; Third Division, (\$5,270.00 to  
8. \$7,375.00) \$5,270.00 to \$9,040.00; Second and Fourth  
9. Divisions, (\$5,570.00 to \$7,675.00) \$5,570.00 to \$9,340.00.  
10. Section 3. This Act shall become effective July 1, 1955.
