3 IN THE LEGISLATURE OF THE TERRITORY OF ALASKA

4 TWENTY-SECOND SESSION

5 A BILL

6 For an Act entitled: "An Act relating to the registration of
7 aircraft and pilots; amending the first
8 paragraphs of Sections 1 and 2 of Chapter
9 43 Session Laws of Alaska 1951; and de-
10 claring an emergency."

11 BE IT ENACTED BY THE LEGISLATURE OF THE TERRITORY OF ALASKA:

12 Section 1. The first paragraph of Section 1 of Chapter 43
13 Session Laws of Alaska 1951 is amended to read as follows:

14 Section 1. REGISTRATION OF AIRCRAFT. Every owner or
15 operator of an airplane, helicopter or other type of air-
16 craft which is based in Alaska shall register the aircraft
17 with the Department of Aviation WITHIN FIFTEEN DAYS AFTER
18 ENTERING THE TERRITORY OF ALASKA, PROVIDING THE AIRCRAFT
19 REMAINS IN THE TERRITORY LONGER THAN SUCH PERIOD OF FIFTEEN
20 DAYS, AND SHALL RE-REGISTER EACH YEAR BETWEEN THE FIRST AND
21 THIRTY-FIRST DAYS OF JANUARY UNLESS THE FIRST REGISTRATION
22 BE LESS THAN NINETY DAYS PRIOR TO THE MONTH OF JANUARY
23 at such times ^{as} that may be designated by the Director of
24 Aeronautics when, in the judgment of the Alaska Aeronautics
25 and Communications Commission, such registration shall be
26 necessary by reason of emergencies ^{or} or military necessity.

27 Section 2. The first paragraph of Section 2 of Chapter 43
28 Session Laws of Alaska 1951 is amended to read as follows:

29 Section 2. REGISTRATION OF PILOTS. Each aircraft

1 pilot within the Territory shall 7 WITHIN FIFTEEN DAYS OF
2 HIS FIRST FLIGHT WITHIN THE TERRITORY, 7 register with the
3 Department of Aviation upon a form provided for that pur-
4 pose 7 AND SHALL RE-REGISTER EACH YEAR THEREAFTER BETWEEN
5 THE FIRST AND THIRTY-FIRST DAY OF JANUARY UNLESS HIS FIRST
6 REGISTRATION BE LESS THAN NINETY DAYS PRIOR TO THE MONTH OF
7 JANUARY 7 at such times that may be designated by the Director
8 of Aeronautics when, in the judgment of the Alaska Aero-
9 nautics and Communications Commission, such registration
10 shall be necessary by reason of emergencies or military
11 necessity.

12 Section 3. An emergency is hereby declared to exist, and
13 this Act shall take effect immediately upon its passage and
14 approval.
