SENATE JOINT RESOLUTION NO. 3

IN THE LEGISLATURE OF THE TERRITORY OF ALASKA
TWENTY-SECOND SESSION

Requesting the Federal Government
to grant to the Territory of Alaska
a 10.27 Acre Tract of Land and
Improvements Thereon, being a Portion
of the Juneau Subport, Located in
the City of Juneau.

WHEREAS there is owned by the Federal Government within the
City of Juneau, Alaska a tract of land known as the Juneau Subport,
on which has been erected a warehouse and wharf, all of which was
used by the United States Army during World War II as a trans-
shipment port and a portion of which, comprising approximately
10.27 acres and containing the warehouse facility, is now believed
to have become surplus to the needs of the United States Govern-
ment; and

WHEREAS it is understood that approximately 80 feet of the
Juneau Subport wharf may be made available for transfer to the
Territory of Alaska with the 10.27 acre portion of the Subport
property and the remaining portion of approximately 767 feet of
wharf must be retained by the Federal Government for U. S. Coast
Guard, Fish and Wildlife Service and other federal functions; and

WHEREAS the Territory of Alaska has for some time made use
of the warehouse and adjacent area for armory purposes and as a
drill ground for the Alaska National Guard under temporary permit
from the federal government; and

1 WHEREAS the ownership or permanent control and right of use
2 of this facility with a portion of the existing wharf would be of
3 great benefit to the Territory of Alaska for these and other
4 necessary uses; and

5 WHEREAS it is the desire and intent of the Territory of
6 Alaska as herein expressed by the Legislature, to acquire and
7 maintain at the future expense of the Territory, such a portion
8 of the property known as the Juneau Subport;

9 NOW THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE
10 TERRITORY OF ALASKA in regular session assembled, that it is the
11 desire of the Territory of Alaska to acquire in the name and for
12 the benefit of the Territory, a portion of that parcel of land in
13 the City of Juneau known as the Juneau Subport, containing approx-
14 imately 10.27 acres, together with a portion of the existing wharf;
15 and it is the intent of the Legislature if the property be so
16 acquired, to provide for its utilization and maintenance at the
17 expense of the Territory of Alaska; and the proper officials and
18 representatives of the Territory of Alaska are hereby requested
19 to seek the acquisition of such a portion of the Juneau Subport
20 property from the Government of the United States.
