6 For an Act entitled: "An Act pertaining to salaries of school
7 teachers and superintendents in the
8 Territory of Alaska; amending Sections
9 37-6-1 and 37-6-2 ACLA 1949, as last
10 amended by Chapter 176, Session Laws of
11 Alaska 1955; and establishing an effect-
12 ive date."

13 BE IT ENACTED BY THE LEGISLATURE OF THE TERRITORY OF ALASKA:

14 Section 1. Section 37-6-1 ACLA 1949, as last amended by
15 Chapter 176, Session Laws of Alaska 1955, is hereby amended to
16 read as follows:

17 Section 37-6-1. TEACHERS' SALARY RANGES BY DIVISIONS.

18 The Territorial Board of Education and school boards of
19 school districts in the Territory of Alaska shall pay
20 teachers regularly qualified in accordance with the Rules
21 and Regulations of the Territorial Board of Education and
22 employed by them a salary within the following salary
23 ranges: For the First Division. ~~\$4,200.00~~ \$5,000.00
24 to ~~\$8,970.00~~ \$7,720.00; for that portion of the Third
25 Division lying east of 152 degrees West longitude,
26 \$4,540.00 \$5,610.00 to \$6,310.00 \$8,330.00; for that
27 portion of the Third Division lying west of 152 degrees
28 West longitude, and the Second and Fourth Divisions,
29 \$4,800.00 \$6,020.00 to \$6,570.00 \$8,740.00.

1 Section 2. Section 37-6-2 ACLA 1949, as last amended by
2 Chapter 176, Session Laws of Alaska 1955, is hereby amended to
3 read as follows:

4 Section 37-6-2. SUPERINTENDENTS' SALARY RANGE BY
5 DIVISIONS. The Territorial Board of Education and school
6 boards of school districts in the Territory of Alaska shall
7 pay superintendents, regularly qualified in accordance with
8 the Rules and Regulations of the Territorial Board and em-
9 ployed by them a salary within the following salary ranges:
10 For the First Division, ~~/\$4,870.00/~~ \$6,070.00 to ~~/\$7,890.00/~~
11 \$9,890.00; for that portion of the Third Division lying
12 east of 152 degrees West longitude ~~/\$5,270.00/~~ \$6,470.00
13 to ~~/\$8,290.00/~~ \$10,290.00; for that portion of the Third
14 Division lying west of 152 degrees West longitude, and the
15 Second and Fourth Divisions, ~~/\$5,570.00/~~ \$6,770.00 to
16 ~~/\$8,590.00/~~ \$10,590.00.

17 Section 3. Funds to carry out the provisions of this Act may
18 be appropriated in the General Appropriations Bill of the Alaska
19 Legislature.

20 Section 4. This Act shall become effective July 1, 1957.
