5 A BILL

6 For an Act entitled: "An Act to require all persons, business
7 associations, and legal entities furnishing
8 or bidding to furnish contractual services,
9 materials or supplies to the Territorial
10 Government or any agency thereof, or to any
11 public utility district, school district, or
12 municipality of the first, second, or third
13 class, to be licensed under the Alaska Busi-
14 ness License Act; amending Sec. 3 of Art. IV,
15 Ch. 82, SLA 1955 amending Sec. 49-2-21, ACLA
16 1949 as amended by Ch. 75, SLA 1949 and Ch.
17 21, SLA 1951 and Ch. 105, SLA 1953 as here-
18 after amended, by adding a new paragraph
19 thereto; amending Sec. 16-1-35, ACLA 1949 by
20 adding a new subsection Twenty-ninth thereto;
21 amending Sec. 16-2-5, ACLA 1949 by adding a
22 new subsection Twelfth thereto; amending Sec.
23 5 of Ch. 46, SLA 1951; and amending Ch. 3 of
24 Title 37, ACLA 1949 as amended by Chs. 52 and
25 61, SLA 1949, Chs. 23, 24, 51, 77 and 96, SLA
26 1951, Chs. 68 and 124, SLA 1953, and Chs. 49
27 and 63, SLA 1955."

28 BE IT ENACTED BY THE LEGISLATURE OF THE TERRITORY OF ALASKA:

29 Section 1. Sec. 3 of Art. IV, Ch. 82, SLA 1955, is hereby

1 amended by adding the following subsection (5) thereto:

2 (5) Every person, business association or legal entity,
3 except an agency of the federal, territorial, or local govern-
4 ment, furnishing, or bidding to furnish, contractual services,
5 materials or supplies shall have a valid Alaska Business
6 License. All sealed bids and invoices for the furnishing of
7 such services, materials or supplies shall contain the serial
8 number of the vendor's Alaska Business License, the type of
9 business for which the license was issued, and the date of
10 issuance. No contract shall be awarded, nor shall any invoice
11 be paid upon any bid or invoice that does not contain such
12 information, or upon the bid or invoice of any person or firm
13 which does not have a valid Alaska Business License.

14 Sec. 2. Sec. 49-2-21, ACIA 1949, as amended by Ch. 75,
15 SLA 1949 and Ch. 21, SLA 1951 and Ch. 105, SLA 1953, is hereby
16 amended by adding a new paragraph to read as follows:

17 Every person, business association or legal entity,
18 except an agency of the federal, territorial, or local govern-
19 ment, furnishing, or bidding to furnish, contractual services,
20 materials or supplies to any public utility district shall
21 have a valid Alaska Business License. All sealed bids and
22 invoices for the furnishing of such services, materials or
23 supplies shall contain the serial number of the vendor's
24 Alaska Business License, the type of business for which the
25 license was issued, and the date of issuance. No contract
26 shall be awarded, nor shall any invoice be paid upon any bid
27 or invoice that does not contain such information, or upon
28 the bid or invoice of any person or firm which does not have
29 a valid Alaska Business License.

11 Sec. 3. Sec. 16-1-35, ACLA 1949, is hereby amended by adding
12 a new subsection thereto to read as follows:

13 Twenty-Ninth: Every person, business association or
14 legal entity, except an agency of federal, territorial, or
15 local government, furnishing, or bidding to furnish, con-
16 tractual services, materials or supplies to any municipality
17 of the first class shall have a valid Alaska Business License.
18 All sealed bids and invoices for the furnishing of such
19 services, materials or supplies shall contain the serial
20 number of the vendor's Alaska Business License, the type of
21 business for which the license was issued, and the date of
22 issuance. No contract shall be awarded, nor shall any
23 invoice be paid upon any bid or invoice that does not contain
24 such information, or upon the bid or invoice of any person
25 or firm which does not have a valid Alaska Business License,

26 Sec. 4. Sec. 16-2-5, ACLA 1949, is hereby amended by adding
27 a new subsection thereto to read as follows:

28 Twelfth: Every person, business association or legal
29 entity, except an agency of the federal, territorial, or local
30 government, furnishing, or bidding to furnish contractual
31 services, materials or supplies to any municipality of the
32 second class shall have a valid Alaska Business License. All
33 sealed bids and invoices for the furnishing of such services,
34 materials or supplies shall contain the serial number of the
35 vendor's Alaska Business License, the type of business for
36 which the license was issued, and the date of issuance. No
37 contract shall be awarded, nor shall any invoice be paid upon
38 any bid or invoice of any person or firm which does not have
39 a valid Alaska Business License.

1 Sec. 5. Sec 5 of Ch. 46, SLA 1951 is hereby amended to
2 read as follows:

3 Section 5. The trustees of such municipal corporation
4 of the third class shall have the same powers as those con-
5 ferred by Section 16-2-5, ACLA 1949, as may be amended here-
6 after, upon trustees of municipalities of the second class.

7 Sec. 6, Ch. 3 of Title 37, ACLA 1949, as amended, is hereby
8 amended by adding a new Article VI thereto to read as follows:

9 ARTICLE VI

10 GENERAL PURCHASING REQUIREMENTS

11 Sec. 37-3-71. BIDS AND PURCHASES. Every person,
12 business association or legal entity, except an agency of
13 the federal, territorial, or local government, furnishing,
14 or bidding to furnish, contractual services, materials or
15 supplies to any school district shall have a valid Alaska
16 Business License. All sealed bids and invoices for the
17 furnishing of such services, materials or supplies shall
18 contain the serial number of the vendor's Alaska Business
19 License, the type of business for which the license was
20 issued, and the date of issuance. No contract shall be
21 awarded, nor shall any invoice be paid upon any bid or invoice
22 that does not contain such information, or upon the bid or
23 invoice of any person or firm which does not have a valid
24 Alaska Business License.
