6 For an Act entitled: "An Act pertaining to the regulation of the  
7 vocations of hairdressing and beauty culture;  
8 amending Subsec. (11) of Sec. 1, and Subsec.  
9 (1)(a), Subsec. (4), and Subsec. (5) of Sec.  
10 4, Ch. 52, SLA 1957."

11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

12 Section 1. Subsec. (11) of Sec. 1, Ch. 52, SLA 1957 is here-  
13 by amended to read as follows:

14 (11) Student. A student is any person of the age  
15 of ~~SEVENTEEN~~ sixteen years or older who has completed two  
16 years of high school or who has equivalent education, who  
17 attends a duly licensed beauty school and who does not re-  
18 ceive any wage or commission, and for whose work no charge  
19 is made until said student has had at least 350 hours of  
20 training.

21 Sec. 2. Subsec. (1)(a) of Sec. 4, Ch. 52, SLA 1957 is here-  
22 by amended to read as follows:

23 (a) He shall have attained the age of ~~17~~  
24 eighteen years.

25 Sec. 3. Subsec. (4) of Sec. 4, Ch. 52, SLA 1957 is hereby  
26 amended to read as follows:

27 (4) Admission without examination. A person who  
28 has been examined and issued a license by a board of cosme-  
29 tology in any state, territory, or the District of Columbia

1 may be licensed in Alaska without examination and upon  
2 payment of a fee of \$25.00.

3 Sec. 4. Subsec. (5) of Sec. 4, Ch. 52, SLA 1957 is hereby  
4 amended to read as follows:

5 (5) License fees. The fees for various licenses  
6 and renewals thereof under this Act shall be as follows:
