5 A BILL

6 For an Act entitled: "An Act appropriating the sum of \$76,120.00  
7 for the operating expenses of the Legisla-  
8 ture and the Legislative Council; supplement-  
9 ing appropriations made by Ch. 2 and Ch. 7,  
10 SLA 1959; transferring certain unused appro-  
11 priations made by Ch. 7, SLA 1959; and  
12 providing for an effective date."

13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

14 Section 1. The sum of \$14,680.00 or so much thereof as shall  
15 be found necessary is hereby appropriated out of the available  
16 moneys in the state treasury to supplement the appropriation made  
17 by subsection (1) of Sec. 1, Ch. 7, SLA 1959, said sum to be  
18 available for expenditure as of March 27, 1959 and to be expended  
19 in conformity with the rates established by Ch. 6, SLA 1959.

20 Sec. 2. Any balances remaining in the appropriation made by  
21 subsection (5) of Sec. 1, Ch. 7, SLA 1959 are hereby transferred  
22 for the purposes set forth in subsection (2) of that Act.

23 Sec. 3. The sum of \$200.00 or so much thereof as shall be  
24 found necessary is hereby appropriated out of the available moneys  
25 in the state treasury to supplement the appropriation made by sub-  
26 section (3) of Sec. 1, Ch. 7, SLA 1959, said sum to be available  
27 for expenditure as of March 27, 1959.

28 Sec. 4. The sum of \$3,000.00 or so much thereof as shall be  
29 found necessary is hereby appropriated out of the available moneys

1 in the state treasury to supplement the appropriation made by sub-  
2 section (4) of Sec. 1, Ch. 7, SLA 1959.

3       Sec. 5. The sum of \$48,000.00 or so much thereof as shall be  
4 found necessary is hereby appropriated out of the available moneys  
5 in the state treasury to supplement the appropriation made by  
6 Sec. 1, Ch. 2, SLA 1959, said sum to be available for expenditure  
7 as of March 27, 1959 and to be expended in conformity with the  
8 rate established by Sec. 1, Ch. 1, SLA 1959.

9       Sec. 6. The sum of \$4,240.00 or so much thereof as may be  
10 found necessary is hereby appropriated out of the available moneys  
11 in the state treasury to continue the work of the Legislative  
12 Council.

13       Sec. 7. This Act shall take effect immediately upon its  
14 passage and approval or upon its becoming law without such approval.
