5 A BILL

6 For an Act entitled: "An Act relating to the monetary allowance
7 for guests of the Alaska Pioneers' Home;
8 providing for a monthly allowance of one
9 dollar for each such guest regardless of his
10 income; amending Sec. 51-2-13 ACLA 1949
11 as amended by Ch. 118, SLA 1957; and pro-
12 viding for an effective date."

13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

14 Section 1. Chapter 118, SLA 1957 is hereby amended to read
15 as follows:

16 Every worthy person residing in Alaska, and who shall
17 have been a resident of the Territory continuously for more
18 than five years immediately preceding his application for
19 admission, and who shall be destitute and in need of the
20 aid or benefit of said Home in consequence of physical dis-
21 ability or other cause, shall be entitled to admission thereto
22 subject to the conditions, limitations and penalties pre-
23 scribed by the rules and regulations of the Board. But no
24 person shall be admitted as an inmate to the Alaska Pioneers'
25 Home under the provisions of this Act, where the support and
26 maintenance of such person is imposed by law upon any relative
27 or member of the family of such person.

28 Every person heretofore or hereafter admitted to the
29 Pioneers' Home, except persons admitted under Section 51-2-14

1 AGLA 1949, who receives income from any source whatsoever in
2 excess of Thirty (\$30.00) ~~FIFTEEN (\$15.00)~~ Dollars per
3 month may be required by the Board of Trustees to pay such
4 excess to the Superintendent of said Home immediately upon
5 receipt thereof in payment, or part payment, of the cost of
6 his maintenance.

7 At the end of each month said Superintendent shall trans-
8 mit all such payments to the Territorial Treasurer together
9 with the names of the persons making same and the amount paid
10 by each. Provided, that the Board of Trustees is hereby
11 directed ~~AUTHORIZED~~ to pay the sum of Thirty (\$30.00) ~~TEN~~
12 ~~(\$10.00)~~ Dollars per month to any resident without funds,
13 provided however, funds may be transmitted to a resident on
14 a daily, weekly or other reasonable basis.

15 All moneys thus received shall be covered into the
16 General Fund.

17 Sec. 2. This Act shall be effective immediately upon its
18 passage and approval, or upon its becoming law without such
19 approval.
