5 A BILL

6 For an Act entitled: "An Act transferring between appropriations  
7 made to certain agencies for the fiscal  
8 year ending June 30, 1961; and providing  
9 for an effective date."

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

11 Section 1. The sum of \$50,000 is transferred to the line  
12 item appropriation for Juvenile Code made to the Division of  
13 Welfare, Department of Health and Welfare from the following  
14 line item appropriations for the fiscal year ending June 30, 1961:

- 15 (1) From Aid to Dependent Children, \$40,000  
16 (2) From Old Age Assistance, \$10,000.

17 Sec. 2. The sum of \$20,000 is transferred to the line item  
18 appropriation for contractual services, Probation and Parole,  
19 made to the Division of Youth and Adult Authority from the line  
20 item appropriation for Care of Prisoners, for the fiscal year  
21 ending June 30, 1961.

22 Sec. 3. The sum of \$6,943 is transferred to the line item  
23 appropriation for Juvenile Conservation Camp made to the Division  
24 of Youth and Adult Authority from the line item appropriation for  
25 Care of Prisoners, for the fiscal year ending June 30, 1961.

26 Sec. 4. The sum of \$22,500 is transferred to the line item  
27 appropriation for contractual services made to the Division of  
28 State Police, Department of Public Safety from the following  
29 line item appropriations for the fiscal year ending June 30, 1961:

- 1 (1) From personal services, Office of Commissioner, \$1,500  
2 (2) From commodities, Office of Commissioner, \$1,000  
3 (3) From commodities, Division of State Police, \$20,000.

4 Sec. 5. The following transfers are made among the line  
5 item appropriations made to the Division of Buildings, Department  
6 of Public Works for the fiscal year ending June 30, 1961:

- 7 To personal services, \$16,000  
8 To travel, \$1,500  
9 From contractual services, \$5,500  
10 From commodities, \$12,000

11 Sec. 6. The sum of \$10,000 is transferred to the line item  
12 appropriation for contractual services made to the Anchorage  
13 International Airport, Department of Public Works from the line  
14 item appropriation for commodities for the fiscal year ending  
15 June 30, 1961.

16 Sec. 7. The sum of \$10,000 is transferred to the line item  
17 appropriation for contractual services made to the Fairbanks  
18 International Airport, Department of Public Works from the line  
19 item appropriation for commodities for the fiscal year ending  
20 June 30, 1961.

21 Sec. 8. The sum of \$900 is transferred to the line item  
22 appropriation for Administration, contractual services made to  
23 the Division of Water and Harbor Facilities, Department of Public  
24 Works from the line item appropriation, emergency repair projects  
25 for the fiscal year ending June 30, 1961.

26 Sec. 9. The sum of \$16,800 is transferred to the appropria-  
27 tion made to the Supreme Court from the appropriation made to  
28 the Magistrate's Courts for the fiscal year ending June 30, 1961.

29 Sec. 10. This Act takes effect on the day after its passage

1 and approval or on the day it becomes law without such approval.
