BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

Section 1. The sum of \$858,469 is appropriated from the
12 general fund for the fiscal year ending June 30, 1961, to be

23 Sec. 2. The sum of \$564,750 is appropriated to the Depart-
 24 ment of Health and Welfare for expansion of the Harborview Nursing
 25 Home facility, Valdez.

26 Sec. 3. The sum of \$400,000 is appropriated to the Depart-
 27 ment of Public Works from Federal Transitional Grants in the
 28 general fund for:

29 Preparation of plans and specifications for terminal facilities

1 at Fairbanks and Anchorage International Airports, and
2 architectural, engineering, fiscal, legal or other
3 preliminary costs incident to the sale of International
4 Airport Revenue bonds. Any amounts expended from this
5 appropriation may be repaid to the Federal Transitional
6 Grant account in the general fund from the proceeds of the
7 sale of International Airport Revenue bonds.

8 Sec. 4. This Act takes effect on the day after its passage
9 and approval, or on the day it becomes law without such approval.
