HOUSE BILL NO. 49

IN THE LEGISLATURE OF THE STATE OF ALASKA

SECOND LEGISLATURE - FIRST SESSION

A BILL

For an Act entitled: "An Act relating to the licensing of operators of motor vehicles, providing for a schedule of fees and extending the period of validity of licenses; amending Secs. 9, 14 and 35, Ch. 173, SLA 1959; and providing for an effective date."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

Section 1. Subsec. (1), Sec. 9, Ch. 173, SLA 1959 is amended to read as follows:

(1) The department shall examine every applicant for an operator's license, except as otherwise provided in this section. Such examination shall include a test of the applicant's eyesight, his ability to read and understand highway signs regulating, warning and directing traffic, his knowledge of the traffic laws of the state, and shall include an actual demonstration of ability to exercise ordinary and reasonable control in the operation of a motor vehicle. The department shall make provision for giving an examination either in the community wherein the applicant resides or at a place convenient to the applicant. The fee for examination shall be as prescribed hereafter.

Sec. 2. Sec. 14, Ch. 173, SLA 1959 is amended to read as follows:

Sec. 14. EXPIRATION OF LICENSE. (1) Every operator's

1 license shall expire on the licensee's date of birth, three
2 [TWO] years from the birthdate preceding application. Every
3 such license shall be renewable on, or before, its expiration
4 upon application and payment of the prescribed fee. The
5 department may require an examination of the applicant as
6 upon an original application.

7 Sec. 3. Sec. 35, Ch. 173, SLA 1959 is amended to read as
8 follows:

24 Temporary driver's permit (Sec. 6(3))

25 School bus driver's permit, renewal (Sec. 15)

26 Sec. 4. This Act takes effect on the day after its passage
27 and approval or on the day it becomes law without such approval.
