BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

Section 1. Sec. 37-6-1, ACLA 1949, as repealed and re-enact-

ed by Ch. 179, SLA 1957, is repealed and re-enacted to read:

Sec. 37-6-1. TEACHERS SALARY SCALE BY SENATE DISTRICT.

The school boards of school districts in the state and the

19

state board of education, as the operating school board for

20

schools outside school districts, shall pay regularly quali-

fied teachers employed by them and with public school

22

experience, allowable in accordance with the rules and regu-

lations of the state board of education, a salary which

shall be not less than that set forth in the following scale:

Sec. 2. Sec. 37-6-2, ACLA 1949, as repealed and re-enacted by Ch. 179, SLA 1957, is repealed and re-enacted to read:

Sec. 37-6-2. SUPERINTENDENTS' SALARY SCALE BY SENATE DISTRICT. The school boards of school districts in the state and the state board of education, as the operating school board for schools outside school districts, shall pay regularly qualified superintendents employed by them the salary for which they qualify on the teachers' schedule plus the following differentials:

Superintendent of 85% to 100% schools . . . \$ 1,200

1 Superintendent of 80% schools . . . . . \$ 1,800  
2 Superintendent of 75% schools . . . . . 2,400

3 Sec. 3. Sec. 37-6-3, ACLA 1949, as repealed and re-enacted  
4 by Ch. 179, SLA 1957, is repealed and re-enacted to read:

5 Sec. 37-6-3. AMOUNTS ESTABLISHED ABOVE SALARY SCALE  
6 FOR PRINCIPALS, VICE-PRINCIPALS, HEAD TEACHERS, AND TEACHERS-  
7 IN-CHARGE. The school boards of school districts within the  
8 state and the state board of education, as the operating  
9 school board for schools outside school districts, shall pay  
10 regularly qualified principals, vice-principals, head  
11 teachers, and teachers-in-charge employed by them a salary  
12 on the teachers' salary scale for the Senate District in  
13 which employed, plus the following amounts in all districts:

14 Principals . . . . . \$ 800  
15 Vice-principals . . . . . 400  
16 Head Teachers . . . . . 400  
17 Teachers-in-Charge . . . . . 200

18 Sec. 4. This Act takes effect on the day after its passage  
19 and approval or on the day it becomes law without such approval.
